Whereas, the attached 2008 Fee Shelter Schedule and recommendation point to needed changes in the operations of the parks in Liberty Township more efficient , and

NOW, THEREFORE BE IT RESOLVED BY THE BOARD OF TRUSTEES OF LIBERTY TOWNSHIP, DELAWARE COUNTY, OHIO: hereby ratifies the changes to the 2008 shelter schedule with all existing fees, including the following changes:

- 1) Raising the resident shelter fee from \$33.00 to \$45.00/day
- 2) Lowering the non-resident shelter fee from \$100.00 to \$55.00/day
- 3) Raising the resident shelter fee for "Families over 100" from \$47.00 to \$60.00/day
- 4) Lowering the non-resident shelter fee "Families over 100" from \$100.00 to \$75/day



Subject: Shelter fee schedule.

The staff at Liberty Park has some concerns over the shelter fee schedule. The biggest concern is a Township resident only pays \$33.00 for a shelter per day, while a non resident would have to pay \$100.00 for a shelter per day. The gap is so wide people will not pay \$100 for a shelter. A non resident will have a Township resident fill out the reservation form and pay \$33.00. I respectfully request raising the resident fee from \$33.00 to \$45.00, while lowering the non resident fee from \$100.00 to \$55.00. I would also request raising the Families over 100 from \$47.00 to \$60.00 while lowering the nonresident rate to \$75.00 from \$100.00. The raising of the resident fee will also help offset the costs of the increase in trash liners and restroom supplies as well as trash removal fees. The other reason to lower the non resident fees is there was not one shelter rented this year from a non resident family. The Township is losing money by the large gap in the fees, the shelter rental comparison that was compiled shows these areas need to be corrected.

GENERAL RULES

Please check with park personnel before using baseball, softball, and soccer fields. These fields may be reserved or closed for maintenance.

Applications are available at the park office between 9 a.m. and 3 p.m. Monday thru Friday only.

All fees are due upon registration approval.

All park facilities are closed at dusk.

No rollerblading, skateboarding or roller skating on tennis courts.

No pets are permitted within shelterhouses, gamecourt areas, or athletic fields.

Walk on use is permitted, however walk on users must relinquish all facilities to permit holders.

Courtesy rule: (1) hour court time limit for walk on users, provided other users are waiting.

No driving or parking on the grass for loading or unloading.

Any unusual events like dunking machines, jumping apparatus etc, must be discussed with park supervisor before the event is held.
