NOW, THEREFORE BE IT RESOLVED BY THE BOARD OF TRUSTEES OF LIBERTY TOWNSHIP, DELAWARE COUNTY, OHIO authorizes the purchase of two (2) sets of turn-out gear and accessories for the amount of \$4,483.11 to be paid to Phoenix Safety Outfitters of Springfield, Ohio.

This Resolution shall be in force and become effective immediately upon its execution.


