Approve one or more solar-powered radar speed signs on Creighton Drive in the Wedgewood Park Estates Subdivision

WHEREAS, Wedgewood Park Estates residents have submitted a petition and are requesting the installation of one or more solar-powered radar speed signs on Creighton Drive in the Wedgewood Park Estates Subdivision, and

WHEREAS, residents have expressed concern that Creighton Drive is a heavily traveled residential street which serves as the primary route for travel through the neighborhood, and

WHEREAS, if approved the residents of Wedgewood Park Estates commit to purchase, insure and maintain the radar speed sign(s) as reasonably directed by the Liberty Township Trustees,

NOW, THEREFORE BE IT RESOLVED BY THE BOARD OF TRUSTEES OF LIBERTY TOWNSHIP, DELAWARE COUNTY, OHIO that the Board accepts the donation of a solar-powered radar speed sign and installation on Creighton Drive in the Wedgewood Park Estates Subdivision with the approval of the Road Superintendent and further authorizes the Township Administrator to execute an agreement with the Homeowners Association to pay for all maintenance costs.

We the undersigned residents of Creighton Drive in Wedgewood Park Estates, a residential subdivision located in Liberty Township, Ohio, hereby petition the Liberty Township Trustees for the installation of one or more solar-powered radar speed signs on Creighton Drive in lieu of (or in addition to) the standard-issued speed limit sign(s) presently installed on Creighton Drive. The residents of WPE, acting by and through the Wedgewood Park Estates Homeowner's Association, commit to purchase, insure and maintain the radar speed sign(s) as reasonably directed by the Liberty Township Trustees.

Creighton Drive is a heavily-traveled residential street which serves as the primary route for travel through the neighborhood. Additionally, although Creighton Drive was not designed to carry significant amounts of non-neighborhood traffic, there is ample evidence to suggest that Creighton Drive increasingly is being used by non-residents as a cut-through from S.R. 750 to S.R. 257.

We respectfully request the Trustees approve this request promptly in order to make Creighton Drive safe for the residents of Wedgewood Park Estates.
