 - Survey or plan of the property proposed to be rezoned, showing locations, dimenstions and uses of all existing structures (all drawings must be to scale, and must be folded to fit into legal-size folder); AND
 - Any other supporting documentation in regard to this application.

You will need to work within the Liberty Township Zoning Regulations and the Comprehensive Plan, both of which are available for review or purchase at the zoning office, or on the internet at www.libertytwp.org
