WHEREAS, the 2017 Fire Department budget has been approved and funds are available for this purchase, and

WHEREAS, the Fire Department will be purchasing two vehicles, a 2018 Ford F-150 and a 2018 Ford Fusion, as detailed below and in coordination with a vehicle purchase being made by the City of Columbus in order to secure the lowest, best price possible.

NOW, THEREFORE BE IT RESOLVED, BY THE LIBERTY TOWNSHIP BOARD OF TRUSTEES, DELAWARE COUNTY, OHIO, to authorize the expenditure not to exceed \$56,188.00 for the purchase of the following two Fire Prevention vehicles:

- b. Lights/Sirens - \$3,120.00
- c. Strip - \$1,300.00

- c. Stripe \$1,300.00
