**PREAMBLE**

**WHEREAS**, on June 16, 2008, the Board approved Resolution No. 08-0616-01 (A Resolution Adopted Pursuant to Ohio Revised Code § 505.94 Prohibiting the Sale of Goods, Offer for Sale of Goods and Solicitation of Orders for Future Delivery of Goods by Transient Vendors within the Unincorporated Territory of Liberty Township, Delaware, County, Ohio) ("Resolution"); and,

**WHEREAS**, the Board must rescind the Resolution because of amendments to R.C. § 505.94, pursuant to HB 49, GA 132, effective September 29, 2017, which no longer authorize the Board to enforce the Resolution.

**RESOLUTION**

**NOW THEREFORE, BE IT RESOLVED:**

1. Resolution No. 08-0616-01 (A Resolution Adopted Pursuant to Ohio Revised Code § 505.94 Prohibiting the Sale of Goods, Offer for Sale of Goods and Solicitation of Orders for Future Delivery of Goods by Transient Vendors within the Unincorporated Territory of Liberty Township, Delaware, County, Ohio) is rescinded. Resolution No. 08-0616-01 hereinafter shall be void and have no effect.

2. All formal actions of this Board concerning and relating to the passage of this Resolution were adopted in an open meeting of the Board, and all deliberations of this Board and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including R.C. § 121.22.
3. This Resolution shall be in full force and effect immediately upon adoption.
