

**RESOLUTION #17-1002-03: ACCEPTING THE RATES AS DETERMINED BY THE BUDGET COMMISSION AND AUTHORIZING THE NECESSARY TAX LEVIES AND CERTIFYING THEM TO THE COUNTY AUDITOR**

**Whereas**, the Board of Trustees in accordance with the provisions of law must adopted a Tax Budget for the fiscal year commencing January 1, 2018;

**Whereas**, the Budget Commission of Delaware County has certified its action thereon to this Board together with an estimate by the County Auditor of the rate of each tax necessary to be levied by this Board, and what part thereof is without, and what part within, the ten mill tax limitation

**Whereas**, the certification made by the Delaware County Budget Commission is shown in attachment Schedule A, Summary of Amounts Required From General Property Tax Approved by Budget Commission and County Auditor's Estimated Tax Rates,

**NOW, THEREFORE BE IT RESOLVED BY THE BOARD OF TRUSTEES OF LIBERTY TOWNSHIP, DELAWARE COUNTY, OHIO:**

1. That the rates provided by the Budget Commission and County Auditor in Schedule A are accepted.
2. That there be and is hereby levied on the tax duplicate of the Township the rate of each tax necessary to be levied within and without the ten-mill limitation as specified in Schedule A.
3. That the Fiscal Officer is directed to certify a copy of this Resolution to the County Auditor.






