NOW, THEREFORE BE IT RESOLVED BY THE BOARD OF TRUSTEES OF LIBERTY TOWNSHIP, DELAWARE COUNTY, OHIO, to declare the Fire Department 2007 Dodge Durango with VIN # 1D8HB38P17F565589 unfit for use under the ORC 505.10(A) and to remove this vehicle from the inventory; and further authorizes the private sale of this vehicle under ORC 505.10(A)(2)(a) to the Jacksonville Volunteer Fire Department, 34 S. Sixth Street, Jacksonville, OH in the amount of \$200.00.
