Authorizing the purchase of equipment for the Parks and Road Services Department

WHEREAS, the Park Department has five 2016 John Deere mowers purchased as part of a warranty program and that are now due for trade-in for replacement equipment with new warranties, and

WHEREAS, staff has found that this program is most cost effective due to the heavy daily use of these mowers and operational efficiency of maintaining newer equipment with warranties, which save on repairs, maintenance costs and downtime caused by older equipment, and

WHEREAS, the Park Department is also in need of purchasing a new gator which can be purchased from the same vendor, and

WHEREAS, the Park Department has budgeted for such equipment and is intending to purchase all the equipment noted above from the state bid process (contract STS515 #800276 and #800237).

NOW, THEREFORE BE IT RESOLVED, BY THE LIBERTY TOWNSHIP BOARD OF TRUSTEES, DELAWARE COUNTY, OHIO, to approve the equipment trade-ins of the above referenced equipment and the purchase of five new mowers and one Gators in an amount not to exceed \$20,248.53 (\$77,128.06 total cost for five mowers less \$63,900.00 trade-in values and \$7,020.47 total cost for gator) as detailed on the attached quotes and payable to JD Equipment, Inc. 1660 US Route 42 NE, London, OH 43140.


