



General Rules

- ❖ Please check with park personnel before using baseball, softball, and soccer fields. These fields maybe reserved or closed for maintenance.
- ❖ Applications are available at the park office between 9 a.m. and 3 p.m., Monday thru Friday or on-line at www.libertytwp.org.
- ❖ All fees are due upon registration approval.
- ❖ All Park facilities are closed at dusk.
- ❖ No rollerblading, skateboarding or roller skating on tennis courts.
- ❖ No pets are permitted within shelter houses, game court areas, or athletic fields.
- ❖ Walk on use is permitted, however walk on users must relinquish all facilities to permit holders.
- ❖ No driving or parking on the grass for loading or unloading.
- ❖ Courtesy Rule: One (1) hour court time limit for walk on users, provided other users are waiting.
- ❖ Any unusual events like dunking machines, jumping apparatus, etc. must be discussed and approved with the park supervisor before the event is held.
- ❖ No use of water balloons without prior approval from the park supervisor.

LIBERTY PARK **Rules & Regulations**

Hours of Operation: Liberty Park will be open daily from 9 am until sunset. Only persons participating in a scheduled program or who have reserved facilities are permitted in the park after sunset or before 9 am. Liberty Park will be closed on the following holidays: New Year's Day, Martin Luther King Day, President's Day, Easter Sunday, Veterans Day, Thanksgiving and Christmas.

General Rules:

- The maximum occupancy for any shelter or pavilion at any time is ninety-two (92).
- Defacement, destruction, removal or disturbance of any building, sign, equipment or natural vegetation within the park is prohibited.
- No persons shall bring to, leave behind, or dump any materials of any kind in the park except the refuse, ashes, garbage and other materials of a picnic, camp or other permitted activities. Such materials shall be deposited in the receptacles provided.
- Fire, other than in grills/fireplaces, is prohibited. All fires must be extinguished before leaving the park.
- Pets must be on a leash and/or controlled by their owners at all times. Owners of pets will be responsible for removal and proper disposal of droppings left behind by said animals. No animals are permitted around the concession, athletic fields or tot-lots. No horseback riding is permitted in the park.
- No persons shall possess, consume or display any alcoholic beverages or any unprescribed drugs in the park. No persons are permitted on the park grounds while under the influence of alcohol or unprescribed drugs.
- No persons shall use or discharge firearms, air or gas guns, bows, crossbows, missile throwing objects or sling shots in the park.
- No persons shall operate radios, musical instruments or any device which emits music/sound at a volume audible beyond their immediate area.
- Soliciting, sales and advertising of any kind on park grounds is prohibited without express permission from the Park Supervisor.
- Minor children under the age of twelve (12) shall be escorted by or under the supervision of responsible parents, guardians or adults at all times. Parents of minor children under the age of eighteen (18) are at all times responsible for the actions and safety of their children while on the park property.
- Any person using an athletic field or game court in the park shall limit duration of usage to one (1) hour when other people are waiting to use said field or court unless reserved ahead of time.
- All organized athletic events must be approved by the Park Supervisor.
- No person shall fly remote control airplanes and/or drones or shoot rockets or fireworks within park limits without permission from the Park Supervisor.
- No swimming in the park's fishing pond; no ice skating without permission from the Park Supervisor. Rollerblading and roller skating are prohibited on the tennis courts.
- Motorized vehicles are allowed on designated roads and only at the displayed speed and shall park only in designated areas. Any vehicle left in the park after closing hours will be removed at the owner's expense.
- No use of water balloons without prior approval from the Park Department.

Compliance with Rules & Regulations: The Park Supervisor or Liberty Township Trustees are authorized to issue orders or directives to park visitors when in their opinion any person in the park is not complying with rules and regulations or are participating in any activities that constitute a hazard to themselves or to others or is in any way being a nuisance or disturbing the peace of the park. Upon continued disregard of said order, directive or prohibition, the offending person(s) may be asked to leave the park or will be ejected by the proper authorities.

Terms of Agreement: All users and persons occupying or using the Liberty Township Park assume the risk of all injuries. All persons or organizations responsible for injury or damage to persons or property agree to hold Liberty Township and all of its officials and employees free and harmless from any and all claims and/or suits of any kind arising out of or in connection with the use of said park by the aforementioned responsible person or organization.
