Authorizing the purchase of equipment for the Parks and Road Services Department

WHEREAS, the Road Department has two ExMark Lazer-72 and one ExMark-60 mowers which are in need of replacement, and

WHEREAS, the Park Department has been utilizing a trade-in program for mowers and has found that it is most cost effective due to the heavy daily use of these mowers and operational efficiency of maintaining newer equipment with warranties, which save on repairs, maintenance costs and downtime caused by older equipment, and

WHEREAS, staff recommends trading in the used equipment noted above and purchasing one Hustler Super-104-35 and one Hustler SuperZ-6027, and

WHEREAS, the Road Services Department has budgeted for such equipment and is intending to purchase all the equipment noted above from the state bid process (contract STS515 #800237).

NOW, THEREFORE BE IT RESOLVED, BY THE LIBERTY TOWNSHIP BOARD OF TRUSTEES, DELAWARE COUNTY, OHIO, to approve the equipment trade-ins of the above referenced equipment and the purchase of one (1) Hustler Super-104-35 and one (1) Hustler SuperZ-6027 in an amount not to exceed \$18,454.15 (\$33,054.15 total cost for two new mowers less \$14,600.00 trade-in values) as detailed on the attached quotes and payable to JD Equipment, Inc. 1660 US Route 42 NE, London, OH 43140.

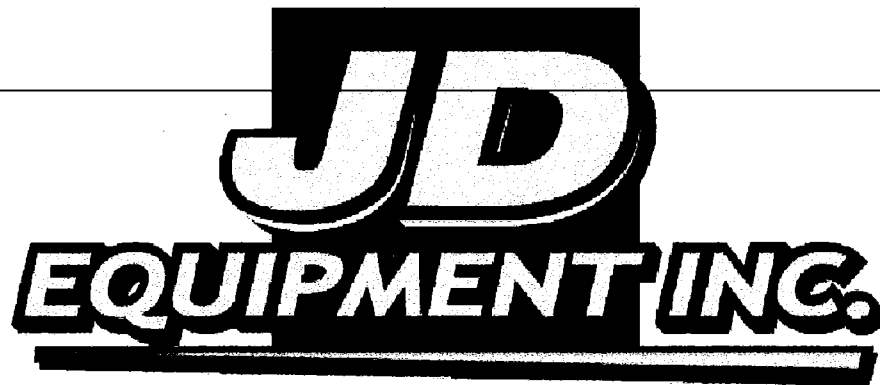
