Authorize Additional Expenditures for Emergency Repairs to Road Department Vehicle

WHEREAS, the Liberty Township Parks and Road Services Department Road Department truck was in need of emergency repairs due to an issue which rendered the vehicle inoperable, and

WHEREAS, the Board of Trustees approved repairs in the amount of \$2,972.49 with Resolution #19-0204-13, and

WHEREAS, it has been determined by the service vendor that additional repairs are needed to make the vehicle operable.

NOW, THEREFORE BE IT RESOLVED BY THE BOARD OF TRUSTEES OF LIBERTY TOWNSHIP, DELAWARE COUNTY, OHIO to authorize an additional expenditure from Road funds for the emergency repair of the Road Department vehicle in an amount not to exceed \$4,916.08 payable to Rush Truck Center, 3950 Parkwest Drive, Columbus, OH 43228; this brings the total cost of the repair to \$7,888.57.


