**Authorize 2019 MS4 NPDES Compliance Charges**

**WHEREAS**, Resolution #09-0420-08 committed Liberty Township to share the responsibility with the Delaware County Engineer's Office associated with the development and implementation of the National Pollutant Discharge Elimination System (NPDES) for Phase II Storm Water requirements which most local governments must comply, and

**WHEREAS**, Liberty Township is designated by law as an operator of a small Municipal Separate Storm Sewer System (MS4), and

**WHEREAS**, DCEO provides the services necessary for the Township to remain compliant and prepares and submits the permit application, and

**WHEREAS**, the Township reimburses the DCEO for the compliance charges associated with the NPDES MS4 permit which are reflected on the attached invoice.

**NOW, THEREFORE BE IT RESOLVED**, by the Liberty Township Board of Trustees, Delaware County, Ohio, to authorize the payment to the Delaware County Engineer, 50 Channing Street, Delaware, Ohio 43015 for 2019 NPDES MS4 Co-Permittee Compliance Charges in the amount of \$15,488.00 from Road Fund.
