Hi Nancy,

Thanks for your email – I had sent it on to our Accounting group to get more information, and just received some updates on this franchise fee issue.

Accounting explained to me that Liberty Township (Delaware County) was historically served by both legacy Time Warner Cable and legacy Insight franchise areas. The Township receives two separate franchise fee payments, one each for the respective legacy areas. The issue we are looking at is specifically for the former Insight area, which is paid separately from the Time Warner Cable area. Accounting has made some formatting changes to the attached spreadsheet so that numbers hopefully are clearer to understand. Again, this issue does not involve the legacy Time Warner Cable area of the Township, it is only the Insight area and payment.

Our Accounting team said that the amounts on the spreadsheet are accurate and consistent with the quarterly payments made in 2016, which were about \$110 per month, for the former Insight franchise area. Accounting has reviewed the numbers again and believes the updated spreadsheet will better show the overpayment.

I hope that this information better explains the situation. Please let me know if you have any additional questions.
