Authorize the Annual Property, Casualty & Liability Insurance Renewal & Payment

WHEREAS, the Property, Casualty & Liability (PC & L) Insurance coverage for Liberty Township through the Ohio Township Association Risk Management Authority (OTARMA) expired on May 23, 2018, and

NOW, THEREFORE, BE IT RESOLVED, BY THE LIBERTY TOWNSHIP BOARD OF TRUSTEES OF DELAWARE COUNTY, OHIO, authorize the renewal payment for Property, Casualty and Liability insurance through Ohio Township Association Risk Management Authority (OTARMA) with liability limits of \$6 million per incident and \$6 million aggregate to protect the Township and its assets, and

BE IT FURTHER RESOLVED, BY THE LIBERTY TOWNSHIP BOARD OF TRUSTEES OF DELAWARE COUNTY, OHIO to authorize payment in the amount of up to \$44,711.00, which is reduction of \$1,040.99 from the 2017 rate, to Ohio Township Association Risk Management Authority (OTARMA) for coverage effective May 23, 2018 through May 23, 2019.
