Whereas, the Board of Trustees approved Resolution 16-0919-09 entering into a cooperative agreement with Delaware County for an Ohio Public Works Commission State Capital Improvement Project to realign Bainbridge Mills, and

Whereas, Resolution 16-0919-09 stated the Township's 14% portion of the project costs would be \$52,650.00, and

Whereas, the total cost for this project has been finalized and the Township cost has been reduced.

Now, Therefore Be it Resolved, that the Liberty Township Board of Trustees, Delaware County, Ohio, approves payment of the Township's 14% portion of the total project cost for the Bainbridge Mills Realignment Project, payable to the Trucco in an amount not to exceed \$58,110.76; \$34,365.88 of which will be reimbursed to the Township by Delaware County bringing the total Township cost for this project to \$23,744.88.

Authorize Cooperative Agreement with Delaware County for Bainbridge Mills Realignment Project

WHEREAS, the Board approved Resolution #15-0908-04 which allowed the Township to participate in an Ohio Public Works Commission (OPWC) State Capital Improvement Project to realign Bainbridge Mills, and

WHEREAS, the Township agreed to provide 14% of the total project cost, which was estimated to be \$550,000 and the Township portion being \$77,000, and

WHEREAS, due to changes in the project, the total project cost has been reduced to \$405,000, therefore, the Township's portion has been reduced to \$52,650.




