You are further notified that **Thursday, October 11, 2018 at 10:00 AM** at the Office of the Board of County Commissioners, 101 North Sandusky Street Delaware, Ohio be and the same is hereby fixed as the time and place for the final hearing by the Commissioners on the report of the County Engineer, and on the proceedings for the improvement, and that all claims for compensation of damages must be filed with the Clerk of the Board of County Commissioners per Section 6131 of the Ohio Revised Code, before that date. The Board shall also hear any evidence offered by any owner for or against the granting of the proposed improvement at this hearing.

If the Commissioners direct the County Engineer to proceed with the project and you wish to pay this assessment rather than have it placed on your real estate tax bill, you must give written notice on the enclosed form and return it to the Commissioners within twenty-one days after the final hearing (by November 1, 2018) and make payment within thirty days after the final hearing (by November 10, 2018). All checks should be made payable to the Delaware County Commissioners, 101 N. Sandusky Street, Delaware, OH 43015. If you do not give notice by November 1, 2018 and make payment by November 10, 2018, the assessment will be placed on your real estate tax bill. Cash funds received in excess of the final costs will be returned to you by the County Auditor after the project has been finalized.


