**IN THE MATTER OF AMENDING RESOLUTION #18-1001-04 OF LIBERTY

**PREAMBLE**

**WHEREAS**, the Board adopted Resolution #18-1001-04 on October 1, 2018; and,

**WHEREAS**, Resolution #18-1001-04 references an Interfund Transfer from Fire Fund 2191 to the Fire TAN Bond Retirement Fund 3103; and,

**WHEREAS**, the description of the action as an "Interfund Transfer" was inaccurate; and,

**WHEREAS**, the correct description of the action authorized by the Board was an "Interfund Advance"; and,

**WHEREAS**, the Board desires to amend Resolution #18-1001-04 to correct said clerical errors.

**A. AMENDMENT OF RESOLUTION #18-1001-04**

**RESOLUTION #18-1001-04: Interfund Advance from Fire Fund 2191 to the Fire TAN Bond Retirement Fund 3103**

**WHEREAS**, due to the failure of the Fire Levy in November, 2012, no property tax revenues were collected for the Fire Department operations in 2013, and

**WHEREAS**, the Board of Trustees issued a Tax Anticipation Note for \$4,800,000 to fund Fire Department operations, and

**WHEREAS**, the final principal and interest payment of \$1,009,700 is due on October 1, 2018, and

**WHEREAS**, the cash balance of Fund 3103 is \$933,484.07, and

**WHEREAS**, the State of Ohio owes the Township an estimated \$77,000 for rollback, which may not be received by the township until after October 1, 2018.

**NOW THEREFORE BE IT RESOLVED BY THE BOARD OF TRUSTEES OF LIBERTY TOWNSHIP, DELAWARE COUNTY, OHIO** to authorize the Fiscal Officer to advance \$76,216 from the Fire Fund 2191 to the Fire Tax Anticipation Note Repayment Fund 3103. The amount advanced to Fund 3103 shall be repaid to Fund 2191 out of the rollback moneys received from the State of Ohio, as well as any excess remaining in Fund 3103 once the final principal and interest have been paid.
