

RESOLUTION #17-0403-06

Authorizing Expenditure for the Purchase of Two Fire Department Vehicles

WHEREAS, the Liberty Township Board of Trustees approved the purchase of two (2) Fire Department vehicles with Resolution #17-0221-19, and

WHEREAS, it is necessary to up-fit these vehicles to fit the needs of the Fire Department with equipment from several vendors, and

WHEREAS, funds have been budgeted and are available for this additional equipment.

NOW, THEREFORE BE IT RESOLVED, THAT THE LIBERTY TOWNSHIP BOARD OF TRUSTEES, DELAWARE COUNTY, OHIO, authorizes the Fire Department to expend funds in the following amounts with the total not to exceed \$28,000.00 for the up-fitting of the command staff vehicles payable to the following vendors: Parr Public Safety Equipment, not to exceed \$17,071.28; Fire & Marine, not to exceed \$5,000.00; Associated Graphics, not to exceed \$3,000.00; and, Motorola not to exceed \$2,074.66.

Chief,
The new staff vehicles were budgeted to be replaced this year. The vehicles were budgeted to not exceed \$105,000. As of today the only expense has been the purchase of the vehicles \$64,846.

The new vehicles should be delivered near the end of April. In order to complete the up-fitting of the vehicles (get the items ordered to facilitate a quick turn-around), the below listed items will be needed. Since there are some minor variables that will come into play, **I would ask that the Board of Trustees pass a resolution not to exceed \$28,000 for the up-fitting of the command staff vehicles.** I am still waiting on exact estimates, but the following prices are "ballpark" estimates from the vendors.

Parr Public Safety Equipment \$17071.28
Fire & Marine \$5,000.00
Associated Graphics \$3,000
Motorola \$2,074.66

I anticipate that these estimates are high, but if they are exact, we will still be \$13,000 below our budgeted amount.
