WHEREAS, Liberty Township has participated in a BWC group retrospective rating program, which continues to be the best option for the Township for 2017, and

WHEREAS, CareWorksComp is the current provider for both Third Party Administrator (TPA) and Managed Care Organization (MCO) services, and

WHEREAS, after reviewing services offered and associated fees from available vendors, staff recommends contracting with CompManagement to act as the Township Third Party Administrator (TPA) for 2017 which will reduce administrative fees by over \$4,300.00.

NOW, THEREFORE BE IT RESOLVED BY THE BOARD OF TRUSTEES OF LIBERTY TOWNSHIP, DELAWARE COUNTY, OHIO to enroll in the Ohio Public Treasurers Group Retrospective Rating Pool administered by CompManagement, LLC, and **further**, to authorize the Township Administrator to sign any and all necessary documents and make payment of the \$3,590.00 administrative fee payable to CompManagement, PO Box 89456, Cleveland, OH 44101-6456.



*Refund is based on 2018 estimated standard premium of \$99,680, which does not include BWC assessments. The actual refund will depend on the performance of the entire group. Group refunds are calculated by comparing merit-rated premium (as paid to BWC) to the group's retrospective premium (minimum premium plus developed claim losses) up to the maximum.

It is important to understand that for a retrospective program to be successful, it must include safety best practices, education, and aggressive claims management to consistently produce positive results. To this point, public employers participating in our group retro programs have earned nearly \$30 million in refunds.
