**IN THE MATTER OF PROHIBITING MARIJUANA CULTIVATION,
DISPENSING, AND PROCESSING IN LIBERTY TOWNSHIP**

The Board of Trustees of Liberty Township, Delaware County, Ohio (“Board”) met in regular session on the 7th day of August, 2017 with the following members present:

M. Beneghan Moved the adoption of the following Resolution:

PREAMBLE

WHEREAS, under R.C. § 3796.29, the Board has the authority to “prohibit, or limit the number of cultivators, processors, or retail dispensaries licensed under . . . [Ohio Revised Code Chapter 3796] within the unincorporated territory of the township;” and,

WHEREAS, the Board finds that it is the best interest of the residents of Liberty Township to prohibit cultivators, processors, and retail dispensaries of medical marijuana, licensed under Ohio Revised Code Chapter 3796, within the unincorporated territory of the Township.

RESOLUTION

NOW THEREFORE BE IT RESOLVED:

1. Pursuant to R.C. § 3796.29, the Board prohibits cultivators, processors, and retail dispensaries of medical marijuana, licensed under Ohio Revised Code Chapter 3796, within the unincorporated territory Liberty Township.
2. The Board directs the Zoning Commission to study amending the zoning resolution to be consistent with this prohibition.

3. All formal actions of this Board concerning and relating to the passage of this Resolution were adopted in an open meeting of the Board, and all deliberations of this Board and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including R.C. § 121.22.
4. This Resolution shall be in full force and effect immediately upon adoption.
